Provision of Concessions for Efficiency Bar Examination for the Officers who are Absorbed/ to be Absorbed into Development Officers' Service

Reference to the provision of concessions for the officers who are absorbed into the Development Officers' Service as per para 14 of the Minute of Development Officers' Service, to pass Efficiency Bar Examinations.

- 02. During the inspection of the personal files of the officers who were absorbed into the Development Officers' Service, it was observed that the officers of the following categories had made requests for relief in respect of the Efficiency Bar Examinations.
 - i. Officers who have not passed any Efficiency Bar Examination since Efficiency Bar Examinations have not been mentioned in the previous recruitment procedure/ Letter of Appointment.
 - ii. Officers who have made requests to get concessions due to non-completion of Efficiency Bar Examination mentioned in the previous recruitment procedure/ Letter of Appointment within due period.
 - iii. Officers who have passed the Efficiency Bar Examination mentioned in the previous recruitment procedure/ Letter of Appointment before the issuance of the letter of absorption and after 01.08.2011.
 - Officers who have not been confirmed in the previous post due to not passing the iv. Efficiency Bar Examination mentioned in the previous recruitment procedure/ Letter of Appointment and passed the first Efficiency Bar Examination after the absorption into the Development Officers' Service
 - Officers who have passed the Second Efficiency Bar Examination after the lapse v. of 3 years after being absorbed into Grade II of Development Officers' Service with effect from 01.08.2011

- 03. Actions were taken to get advice from the Public Service Commission with regard to the appeals made to obtain concessions for Efficiency Bar Examinations and as per the decisions of the Public Service Commission communicated by the letters of the Secretary to the Public Service Commission No PSC/APP/04/2021 dated 13.08.2021 and PSC/APP/4/2/2016 dated 23.10.2020, Annex 01 depicts the way the concessions are granted to the officers who are absorbed/ to be absorbed into the Development Officers' Service with regard to Efficiency Bar Examinations and you are kindly informed to notify relevant officers on the same.
- 04. Officers who are absorbed into the Development Officers' Service should have passed the First Efficiency Bar Examination prescribed in the Recruitment Procedure/ Letter of Appointment of the previous post, within due period of time before 01.08.2011, which is the date on which the Minute of the Development Officers' Service came into effect and it has been informed by the letter of the Secretary to the Public Service Commission No PSC/APP/04/2021 dated 13.08.2021 that the number of sessions is calculated on the basis of conducting one examination session per year.
- 05. Further, in line with the decision of the Public Service Commission, officers who are absorbed into a Grade II post of Development Officers' Service from a Grade III post in the previous Service, with effect from 01.08.2011, should pass the Efficiency bar Examination prescribed for Officers in Grade II of Development Officers' Service within 3 years from the date of issuance of the letter of absorption and the due number of sessions is calculated on the bases of conducting two examination sessions per year. Since only two Efficiency Bar Examinations for Grade II officers of the Development Officers' Service have been held so far (21.04.2018 and 19.01.2020) and since the results have been issued for those examinations, you are kindly informed to pay salary increments only to the officers who have passed the Second Efficiency Bar Examinations as per Serial No 4 of Para 4 in Public Service Commission Circular 03/2016 and who have absorbed into Grade II of Development Officers' Service having satisfied the qualifications mentioned below.
 - i) Have reported the results of the Efficiency Bar Examination to the relevant officer through prescribed form.
 - ii) Have completed the performance reports and moderated by the evaluator and moderator
 - iii) Have satisfied all requirements relevant to the payment of annual salary increment.
- 06. You are further informed to draw your attention to the provisions in the Public Service Commission Circular No 01/2020 issued to be effective from 01.01. 2020 and subsequent circular provisions when the date of promotion of the officers is calculated on satisfying qualifications required for the promotions to Grade II and Grade I of Development Officers' Service.

Providing relief to the Officers who have been absorbed into the Development Officers Service to complete the Efficiency Bar Examinations mentioned in the Service Minute

iv Matters related to Grade Promotion	b)	Officers who have passed the Efficiency Bar Examination during the concessionary period will be promoted to Grade II from the date of completion of 10 years of active service, assuming that they have passed the Efficiency Bar Examination on the due date if they have fulfilled the other required qualifications.
