Calling information on the Statutory Bodies where the Development Officers can be released on a secondment basis for posts outside the public service

Based on the policy decisions of the government, a large number of new officers have been recruited to the Development Officers' service during the period of 2020-2022. Considering the actual staff and the requirement of the Development Officers' staff based on the scope of each ministry or department action is being taken to get the approval from the Director General of Management Services for the number of posts in the Development Officers' service at each institution. It has been observed that there are excess officers in some institutions, whereas there are vacancies in some institutions in the Development Officers' service according to the service requirements.

02. The Development Officers who have been recruited to the public service are attached to office and field duties. As they have enhanced knowledge and abilities by getting higher education in various fields, you are kindly informed to submit me the information prepared in accordance with the following format to consider releasing excess officers on a temporary basis for the posts that have fallen vacant at the Statutory Bodies functioning under the purview of your Ministry in order to obtain a more productive and optimal service from such officers.
